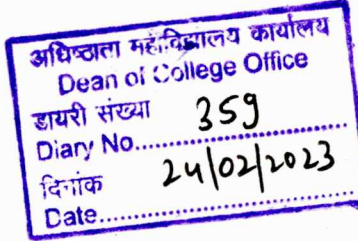

- iv) Installation / Display of QR codes in colleges and faculties of University to enable students to participate in the E-pledge against Drug campaign.
- v) Making E-pledge mandatory for vertical promotion of students in colleges and faculties of University of Delhi as well as for all new coming students.
- vi) Hoardings /banners of Drug awareness messages to be displayed at the Gates and prominent areas of all the colleges.

It is also submitted that Shaheed Bhagat Singh College has been appointed as the nodal agency in South Campus and Sri Ram College of Commerce in North Campus to run this campaign.
